PLAYERS CODE OF CONDUCT

The following PLAYERS CODE OF CONDUCT has been adopted by Ingold Sports Park, hereby referred to as ISP, and Fallbrook Sports Association and will be strictly enforced. Please remember that ISP is a family oriented recreation facility and will make every attempt to maintain these standards for the good of all that use the facilities.

Any player, manager or spectator that does not conduct themselves in a manner that is conducive with ICSP and Fallbrook Sports Association policies or rules will be removed, ejected, or suspended from the facility for any length of time and/or face possible legal action to be determined by ISP management.

NO PLAYER SHALL:

- 1) At any time lay a hand upon, push, shove, bump into, strike, or threaten to strike any player, manager, spectator, official or employee of the park.
- 2) Refuse to abide by an official's decision.
- 3) Display objectionable demonstrations by throwing any piece of equipment in a forceful manner.
- 4) Heap verbal abuse upon any player, manager, spectator or official for any reason.
- 5) Discuss with any official in any manner the decision reached by such official, except the team manager or captain.
- 6) During the game, discuss aloud with the spectators in a derogatory or abusive manner any play, decision or personal opinion of officials or other players.
- 7) Use unnecessary rough tactics in the playing of the game.
- 8) Appear on the field of play, at any time, in an intoxicated condition.
- 9) Smoke while going onto, coming off of, or while in the field of play.
- 10) Be the aggressor in any physical attack upon any player, official, employee or spectator.
- 11) Be relinquished of financial responsibility for his or her team until the entire team fee has been paid in full to the league office.
If the team fee is not paid in full all players on that roster will be suspended from the facility until the fee is paid in full.
- 12) Use profane, obscene or vulgar language at any time.

PLAYER RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT **IMPORTANT-PLEASE READ AS IT MAY AFFECT YOUR RIGHTS**

In consideration of being allowed to participate in any way in the Ingold Sports Park (ISP) athletic/sports program related events and/or activities, the undersigned acknowledges, understands and agrees that:

- 1) The risk of injury from my participation in the sports activities involved in this program is significant, including the potential for permanent paralysis or death and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist, and,
- 2) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASERS or others, and assume full and complete responsibility for any injury or damage arising out of my participation in the ICSP and GO YARD Sports athletic/sports programs, related events and activities; and,
- 3) I willingly agree to comply with the above stated terms and conditions for participation. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest park official immediately; and,
- 4) I hereby release and hold harmless ISP and Fallbrook Sports Association and their agents, employees and officers with respect to any and all claims for injury, loss or damage to person or property, whether arising from the negligence of the releases or otherwise.
